

How should I prepare my vehicle for pick-up when I donate it?



Be sure to remove all of your personal items from the vehicle and leave the rest to us!

Must a vehicle be operational when I donate it?

No. Vehicles do not have to be in running order to be accepted for donation.

Is a title required when I donate a vehicle?

Yes, you do need to have possession of the title to donate the vehicle.


When should I donate my vehicle?

Donate when your vehicle needs repairs that cost more than the vehicle is worth. A vehicle which is old and needs mechanical repairs can still be a valuable donation.

Donate when your late-model vehicle has mechanical problems. While it may be difficult for you to sell this type of vehicle, newer vehicles that have mechanical problems, particularly if not running, may sell for more at the CP lot in Rancho Cordova than you could get selling it yourself, and in turn benefit a great cause through your charitable donation.

Donate when the dealer gives a low trade-in offer. If a dealer is offering you a low trade-in value, please consider donating it. This vehicle may yield excellent results on the CP lot while providing you with a good tax deduction.

Your vehicle donation could help provide:

- Spay or neutering of more than eight animals
- Ensure flea treatment and heartworm protection for five dogs
- Vaccinations for six animals
- Four months of cat litter
- ...and much, much more!

Donating your vehicle can make a big difference in the lives of our four-legged friends. It takes virtually no time, effort or expense. You'll feel good about helping us

help our animals while donating a vehicle you're not using. Sounds easy? It is.

THE DONATION PROCESS

Complete the downloadable donation form available on our website at hsotc.org which includes your contact information and general information specific to the type, year, make, model and approximate mileage of the vehicle. We also will need to know if you are in possession of the vehicle's title. If you have questions or need assistance in completing the form please call 209-984-5489. Once the form is completed, we will send it to our vehicle donation partner, Car Program (CP) LLC.

CP Tows the Vehicle

At no cost to you, CP will contact you to arrange for a convenient time to pick-up the vehicle and provide you with a receipt to be used for tax purposes. Then CP will tow the vehicle to its facility in Rancho Cordova, CA.

CP Sells the Vehicle

CP cleans up your donated vehicle to present it at its best and help garner the highest sales price for the HSOTC. Potential buyers will have the chance to preview the vehicle and make a fair market value offer. Upon the sale of the vehicle, CP takes care of the title transfer and all sale-related paperwork.



HSOTC Receives the Proceeds

The cash your donated car sells for is sent to us so we can continue our mission of saving one animal at a time.

We only ask that you tell your family and friends how easy it is for them to make a difference as well by donating their vehicle to the HSOTC!

VEHICLE DONATION FREQUENTLY ASKED QUESTIONS (FAQ'S)

Is my vehicle donation tax-deductible?

Yes. The HSOTC is a 501(c)(3) non-profit, so your donation is a charitable contribution that can be deducted from your taxes if you itemize deductions. Since not all tax laws apply to all people, go to www.irs.gov for current tax laws and links to IRS publications specific to car donations.

Do you accept all vehicles?

Yes! Our program accepts all type of vehicles including cars, trucks, RV's, sport utilities, motorcycles, boats, jet skis, snowmobiles, trailers, and motor homes.

When I donate my vehicle, is there a towing cost?

There is no cost to you for towing or for anything else. You will be contacted by our vehicle donation partner, Car Program LLC, to establish a mutually agreed upon time for pick-up.
